Silent Ceremony

Following his election by the Livery on Michaelmas Day, on 10 November, Charles Edward Beck Bowman, Alderman and Grocer, was admitted to office as the 690th Lord Mayor of the City of London at the Silent Ceremony in Guildhall.

Lord Mayor's Briefing to Masters and Prime Wardens, and their Clerks

The new Lord Mayor was pleased to be able to address all Masters and Clerks at the briefing on 22 November, setting out his key objectives for the forthcoming year and how he intended to deliver on them. Pan Livery Collaboration

The Pan Livery Collaboration continues to gain support and momentum after a second breakfast held at Mercers' Hall on 22 November, attended by representatives of almost 100 Livery Companies together with key individuals from the City of London Corporation. The working groups established in June presented their findings and the Livery decided to take forward two strands, a communications piece and a philanthropic 'employability' piece. The Business of Trust

The Lord Mayor has recently launched [The Business of Trust](#), a new initiative designed to make a positive difference to public levels of trust in the financial and professional services. This programme of work, which is based on the views of the public and new guiding principles for business, aims for a lasting legacy of better business trusted by society. The programme will be focused around five strands including: inspiring business to operate with integrity and grow their positive impact, supporting businesses and their leaders to meet tomorrow's challenges, and working with others at home and abroad to build trust in business. Late Lord Mayor – Inward Visits

As the Mayoralty of Alderman Dr Andrew Parmley came to a close, the late Lord Mayor hosted a series of follow-up events connected to the overseas visits he had undertaken earlier in the year. Following his visit to Algeria in April, the late Lord Mayor convened and hosted, with the Department for International Trade, a major investment conference at Mansion House in October, to bring to the attention of UK investors the market opportunities available in Algeria, principally in green finance and Public Private Partnerships. A few days later, he chaired a roundtable meeting with a visiting delegation from Georgia, headed by the Deputy Prime Minister and Foreign Secretary of Georgia, to introduce the delegation to key contacts and potential partners in London.

UK-Kazakhstan Investment Forum

The Late Lord Mayor also hosted the UK-Kazakhstan Investment Forum at Mansion House on 8 November. The conference was a follow-up to the successful visit to Kazakhstan earlier in the year, and was intended to position the City as a key player in facilitating closer trade and investment links between the UK and Kazakhstan. Over 150 delegates from the UK and Kazakhstan business and financial communities heard keynote speeches from the Late Lord Mayor, the Prime Minister's Trade Envoy to Kazakhstan, Kazakhstan's Ambassador to the UK, the Deputy Chairman of Kazakh Invest, and the Governor of the Astana International Financial Centre. These speeches were followed by panel discussions on investment opportunities in Kazakhstan and strengthening the links between the City and Astana's financial centre. The key deliverable from the conference was helping to position the London Stock Exchange as the go-to venue for future initial public offerings of Kazakh companies, including large state-owned enterprises, across a diverse range of sectors.

Ward of Portsoken: Aldermanic Election

Following the surrender of office by Alderman Sir Michael Bear, on 14 December an Aldermanic Election was held for the Ward of Portsoken. The result was as follows:

- BARKER, David James - Independent - 20 votes
- CAMPBELL-TAYLOR, William Goodacre - Labour - 143 votes
- GOYAL, Prem Babu - Independent - 228 votes (E)
- SAMUELS, Anthony David – Independent – 2 votes

Prem Goyal was duly elected as Alderman for the Ward.

Ward of Bishopsgate: Result of Common Council Election

On 14 November 2017, an election was held in the Ward of Bishopsgate. The result was as follows:

- BECKER, Timothy George Christie - Independent - 18 votes
- MURPHY, Benjamin Daniel - Independent - 112 votes (E)
- STREETER, Patrick Thomas - Independent - 35 votes

Benjamin Murphy was duly elected as Common Councilman for the Ward.

Livery Schools Link (LSL): Volunteer brokerage platform

LSL's main new project is the development of the volunteer brokerage platform, which aims to match volunteers from Livery Companies with schools helping young people think about the world beyond formal education. The platform now has the following features:

- Motivational talks
- Careers events
- Partners Module: Enabling partners to sign-up to increase volume of volunteering opportunities and volunteers available. e.g. We work with Enterprise Business Councils who arrange various opportunities for schools.
- Livery Members Recommending Trusted Peers: Livery Company members are connected to individuals, often younger people, who are not yet members of Livery Companies but might help with volunteering.
- Multiple Postcode Locations for Volunteers: Volunteers have the ability to specify multiple postcodes for volunteering as sometimes they can volunteer from home or from near their work.
- Recruiting Governors
